Thank you for entering K-9 OTC's agility trial; except for the first classes of the day, all start times are approximate.

**Building opens** at 8 AM Friday, and 6:30 AM Saturday/Sunday. Parking is available in the Think Pawsitive lot; the adjacent lots may be used on Saturday/Sunday ONLY. No street or overnight parking allowed. Food will not be available on site, but there are fast food options nearby.

**Volunteers:** Trials cannot function without volunteers! Worker sign-up can be found at <https://wejoinin.com/secretary@agilgold.com> . Workers will receive lunch, drinks, and snacks.

**Crating space** is available in multiple rooms on two levels. First floor crating space for those handlers physically unable to climb stairs can be secured in advance; please contact the Trial Chair. Crates may be left overnight; however, K-9 OTC & Think Pawsitive LLC will not be responsible for any lost or damaged items left at the show site. Dogs with space issues must be covered and non-disruptive. Dogs may not be left overnight.

PICK UP AFTER YOUR DOGS! Anyone caught not picking up after their dog(s) will be asked to leave without a refund. Remember that hotels are considered by the AKC to be part of the trial site, so exhibitors observed not picking up or causing disturbances at the hotels may face AKC sanctions.

The Trial Secretary is a Volunteer Measuring Official (VMO). *If your dog needs to be measured, please be available at least 1 hour prior to your first run.*

#### **Directions: Remember to follow detour routes and allow for construction.**

From the North: Take US-41 S toward Milwaukee. Merge onto I-94 W via EXIT 38B toward Madison.

Take the MOORLAND RD SOUTH exit, EXIT 301A. Merge to S MOORLAND RD/CR-O S.

Turn RIGHT onto W LINCOLN AVE. Take the 2<sup>nd</sup> LEFT onto COMMERCE DRIVE.

Think Pawsitive is around the curve on the RIGHT.

From the South: Take I-94 W/US-41N toward MILWAUKEE. Merge onto I-43 S via EXIT 316 on the LEFT toward MADISON/FOND DU LAC. Take the CR-O/MOORLAND RD exit, EXIT 57. Merge onto S MOORLAND RD/CR-O N toward BELOIT RD EAST. Turn LEFT onto W LINCOLN AVE. Take the 2<sup>nd</sup> LEFT onto S COMMERCE DR. Think Pawsitive is around the curve on the RIGHT.

From the West:

Take I-94 E. Take the MOORLAND RD exit, EXIT 301A-B. Keep RIGHT at the fork to go on S MOORLAND RD/CR-O S. Turn RIGHT onto W LINCOLN AVE. Take the 2<sup>nd</sup> LEFT onto COMMERCE DR. Think Pawsitive is around the curve on the RIGHT.

**Hotels:** Please double check with the hotel regarding their policy to accept dogs as this is subject to change.

➤ Judging begins each day in Ring 1 with Time 2 Beat, and will then alternate between the two rings as follows:

**Saturday/Sunday** - Time 2 Beat, Master/Exc Std, Master/Exc JWW, Open Std, Open JWW, Novice Std, then Novice JWW.
