Thank you for entering the K-9 OTC agility trial; except for the first classes of the day, all start times are approximate.

If you are willing to help set up, the building will be available for crate setup Thursday night at 4 PM. The building will open Friday at 7:30 AM; Saturday/Sunday at 6:30 AM. Parking is available in the Think Pawsitive lot; no street or overnight parking allowed. Food will not be available on site, but there are fast food options nearby.

Friday is "*Charge Against Cancer*" day! All proceeds from the day's trial will be donated to the Charge Against Cancer fund for canine cancer research at UW Madison. As a thank you, lunch will be provided to all exhibitors on Friday. Please support our silent auction and our efforts to eradicate cancer in our agility partners.

Volunteers: Trials cannot function without volunteers! Volunteer sign-up can be found by clicking on the VOLUNTEERS link at www.agilgold.com. Volunteers will receive lunch, drinks, snacks, and coupons for future entries.

Crating space is available in multiple rooms on two levels. First floor crating space for those handlers physically unable to climb stairs can be secured in advance; please contact the Trial Chair. Crates may be left overnight; however, K-9 OTC & Think Pawsitive LLC will not be responsible for any lost or damaged items left at the show site. Dogs with space issues must be covered and non-disruptive. Dogs may not be left overnight.

PICK UP AFTER YOUR DOGS! Anyone caught not picking up after their dog(s) will be asked to leave without a refund. Remember that hotels are considered by the AKC to be part of the trial site, so exhibitors observed not picking up or causing disturbances at the hotels may face AKC sanctions.

The Trial Secretary is a Volunteer Measuring Official (VMO). *If your dog needs to be measured, please be available at least 1 hour prior to your first run.* You will need your dog's registration number.

Directions: Remember to follow detour routes and allow for construction.

From the North: Take US-41 S toward Milwaukee. Merge onto I-94 W via EXIT 38B toward Madison.

Take the MOORLAND RD SOUTH exit, EXIT 301A. Merge to S MOORLAND RD/CR-O S.

Turn RIGHT onto W LINCOLN AVE. Take the 2nd LEFT onto COMMERCE DRIVE.

Think Pawsitive is around the curve on the RIGHT.

From the South: Take I-94 W/US-41N toward MILWAUKEE. Merge onto I-43 S via EXIT 316 on the LEFT toward MADISON/FOND DU LAC. Take the CR-O/MOORLAND RD exit, EXIT 57. Merge onto S MOORLAND RD/CR-O N toward BELOIT RD EAST. Turn LEFT onto W LINCOLN AVE. Take the 2nd LEFT onto S COMMERCE DR. Think Pawsitive is around the curve on the RIGHT.

From the West:

Take I-94 E. Take the MOORLAND RD exit, EXIT 301A-B. Keep RIGHT at the fork to go on S MOORLAND RD/CR-O S. Turn RIGHT onto W LINCOLN AVE. Take the 2nd LEFT onto COMMERCE DR. Think Pawsitive is around the curve on the RIGHT.

Hotels: Please double check with the hotel regarding their policy to accept dogs as this is subject to change.
