Thank you for entering the **Blitzen Agility Club of Chicago** agility trial! We hope you have a fun weekend.

PARKING is NOT available in the grassy lot across from Pawsitively Heaven. Parking is permitted in the paved lot by the Lexington Nursing Home. Parking is also permitted at the Chicago Ridge Municipal Parking lot and the Fire Department parking lot (PLEASE do not block doors). Parking spots near the building will be reserved for people working from their vehicles. If you park there and are crating inside, you will be asked to move. If you fail to do so, you could be asked to leave the event without a refund.

Crating is allowed in the building; areas will be marked. All crates and x-pens must have a mat or blanket under them to protect the flooring; the top of the crate must be closed.

Site Rules: Please clean up after your dog. Only use the designated exercise areas. Dogs are not allowed to be off leash outside. Anyone caught not picking up after their dog(s) will be asked to leave without a refund. Remember, hotels are considered by the AKC to be part of the trial site, so exhibitors observed not picking up or causing disturbances at the hotels may face AKC sanctions. Please discard your pet waste in the nearby trashcans.

Food will not be available on site, but fast food is available nearby. Please bring water for you and the dogs.

Online Trial Information: We will be using **Agility Gate**. To download the app and get directions on its use, please visit <https://agilitygate.com>. The access code for this trial is **0812**.

Course Maps: There will not be any running orders or course maps printed for distribution at the trial.

- ❖ Maps for the trial day will be available at Agility Gate and at www.agilgold.com. Please do not email the secretary wondering where they are. They will be posted as soon as possible.
 - If on the morning of the trial you still see a cartoon, refresh/reload the page.

Volunteer sign-up: click on the VOLUNTEERS link at www.agilgold.com. The link will be active through Wednesday, 7/29; after that date you will be able to sign up at the trial. Workers will receive coupons, water, snacks, and lunch.

Measuring Dogs: Please see the secretary if your dog needs to be measured. There will be 3 VMO's present. If you need to be measured and run without being measured first, AKC will remove any legs you may have earned. Novice Handlers that require a first measurement should arrive at least 45 minutes before your first run.

Exhibitors will be allowed ringside to observe the competition. Please keep the areas around the entry and exit gates clear. No dogs will be allowed in the front row.

- ❖ Ribbons & Stickers will be self-serve. Please do not tear label sheets.
- ❖ Individual results will be emailed Monday morning after the trial.

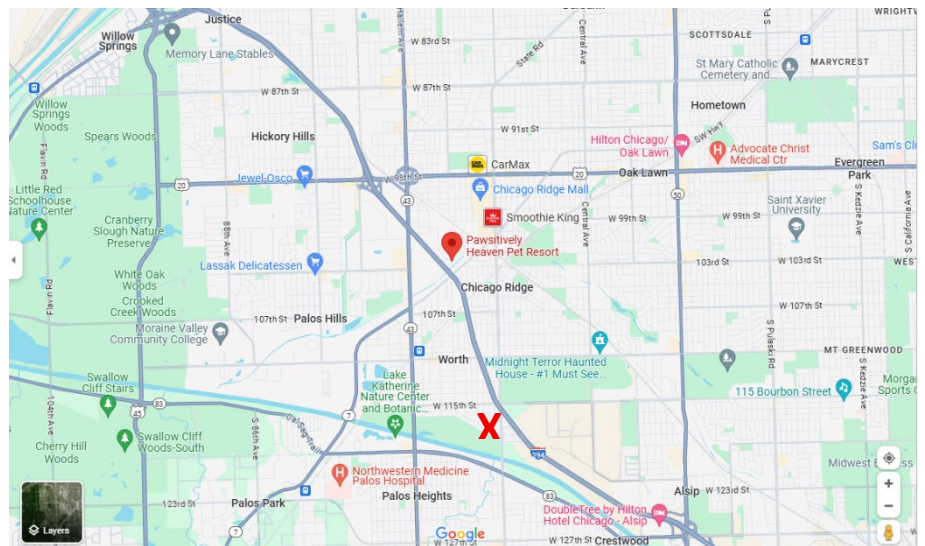
GENERAL INFORMATION

DIRECTIONS:

From the North:

Take I-294 South to 95th Street (Rts. 12/20) and exit East. Stay to the right and take the ramp to Harlem Road South (second ramp). At the first light turn Left onto 99th Street. Go to the stop sign and turn Right onto Sayre Avenue. Turn Left at the next stop sign onto Virginia Avenue. Turn Right at the next stop sign and continue on Virginia Avenue. Pawsitively Heaven will be on the left side of the street, just past the fire station.

From the South:

Take I-294 North to 95th Street (Rts. 12/20) and exit East. Stay in the right lane and take the ramp to Harlem Road South. At the first light turn Left onto 99th Street. Go to the stop sign and turn Right onto Sayre Avenue. Turn Left at the next stop sign onto Virginia Avenue. Turn Right at the next stop sign and continue on Virginia Avenue. Pawsitively Heaven will be on the left side of the street, just past the fire station.

This is the Preliminary Judging Schedule which is contingent on move-ups/withdrawals not yet received.

Running Order within each height will be:

Master, Master Preferred, Exc, Exc Preferred, Open, Open Preferred, Novice B, Novice A, then Novice Preferred.
