Thank you for entering the **Blitzen Agility Club of Chicago** agility trial! **We hope you have a fun weekend.**

**Parking:** Parking is NOT available in the grassy lot across from Pawsitively Heaven. Parking is permitted at the paved lot at the Lexington Nursing Home, Chicago Ridge Municipal Parking lot, the Fire Department parking lot (do not block doors), and along Kitty Ave. Parking spots near the building are reserved for people working from their vehicles. If you park there and are crating inside, you will be asked to move. If you fail to do so, you could be asked to leave without a refund.

Please do not exercise your dogs near the entrances to the building or on the shrubbery. Anyone caught not picking up after their dog(s) will be asked to leave without a refund. Remember, hotels are considered by the AKC to be part of the trial site, so exhibitors observed not picking up or causing disturbances at the hotels may face AKC sanctions. Please discard your pet waste in the nearby dumpsters.

**Food** will not be available on site. Please bring water for you and the dogs.

**Crating:** All crates and x-pens must have a mat or blanket under them to protect the flooring; the top of the crate must be closed. Please be aware there is reserved space for club members and trial secretary.

- Blitzen Agility Club of Chicago and AgilGold Trial Svcs will not be responsible for any lost or damaged items left at the show site. Keep your valuables hidden and bags closed.
- Dogs with space issues must be covered and non-disruptive.

  - No printed copies will be provided. Maps will be posted.

**Volunteer sign-up:** click on the VOLUNTEERS link at [www.agilgold.com](http://www.agilgold.com). The link will be active through Wednesday, 8/31; after that date you'll only be able to sign up at the trial. **Coupons, water, soda, snacks, and lunch will be available to volunteers.**

**Measuring Dogs:** Please see the secretary if your dog needs to be measured; she is a VMO. If you need to be measured and run without being measured first, AKC will remove any legs you may have earned. Novice Handlers that require a 1<sup>st</sup> measurement should arrive at least 45 minutes before your first run.

**Unless getting ready to compete, dogs will NOT be allowed by ring gating or in the first row of spectator seating.**



*Please be aware of other teams as you enter and exit the building. Stairwells can be tight; keep your dog close and look before you suddenly turn the corner. Please use caution when entering/exiting the elevator.*

- ❖ Preliminary results will be displayed on monitors in front of the secretary's table and posted as a jump height/class is completed.
- ❖ Ribbons & Stickers will be self-serve.
- ❖ Individual results will be emailed Monday morning after the trial.

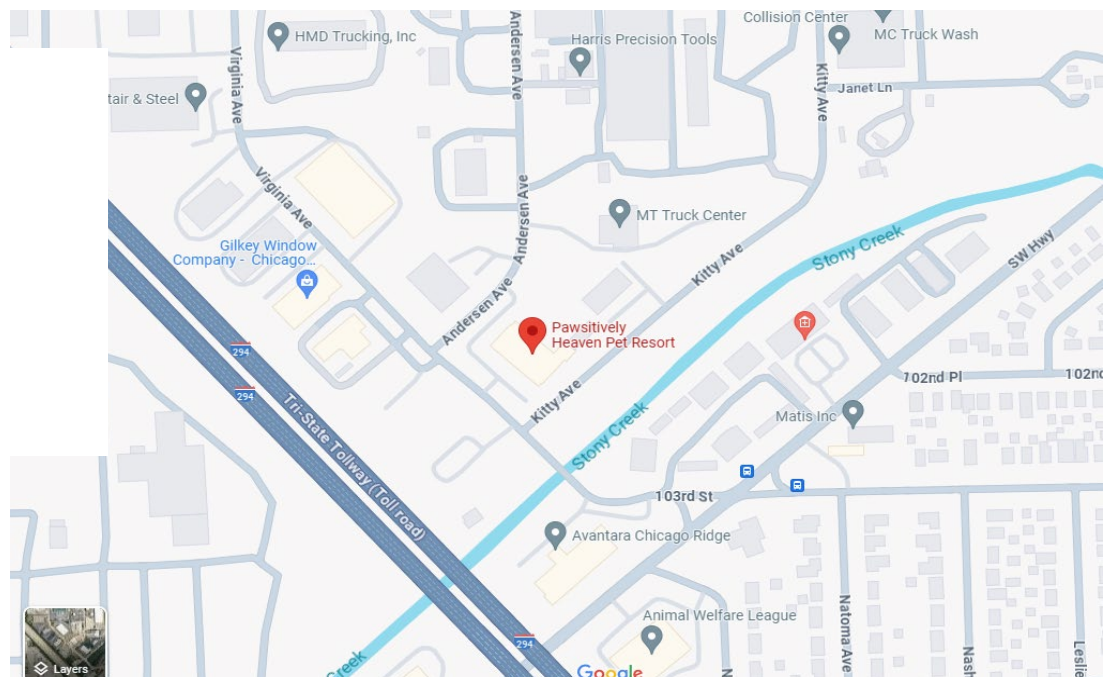
## GENERAL INFORMATION

## DIRECTIONS:

From the north: Take I-294 South to 95th Street (also Route 12/20) and exit East. Stay to the Right and take the ramp to Harlem Road south (second ramp, first will put you back onto I-294 north). At the first light turn Left onto 99th Street. Go to the 2nd stop sign and turn Right onto Sayre Avenue. Turn Left at the next stop sign onto Virginia Avenue. Turn Right at the next stop sign and continue on Virginia Avenue. Pawsitively Heaven will be on the Left side of the street, just past the fire station.

From the south: Take I-294 North to 95th Street (also Route 12/20) and exit East. Stay in the Right Lane and take the ramp to Harlem Road South. At the first light turn Left onto 99th Street. Go to the 2nd stop sign and turn Right onto Sayre Avenue. Turn Left at the next stop sign onto Virginia Avenue. Turn Right at the next stop sign and continue on Virginia Avenue. Pawsitively Heaven will be on the Left side of the street, just past the fire station.

Master, Master Preferred, Exc, Exc Preferred, Open, Open Preferred, Novice B, Novice A, then Novice Preferred.
