Thank you for entering the **Blitzen Agility Club of Chicago** agility trial! **We hope you have a fun weekend.**

We could use your help! Individuals willing to help Blitzen unload equipment and set up for the trial should arrive at 2:00 p.m. Thursday. However, no individual crates, mats, saving spots, etc. will be permitted until the rings are completely set and the trial chair gives the okay. Exhibitors wishing to set up for themselves may arrive after 5 p.m. Thursday.

**Parking:** Those with RV's can park on the west side of the building.

Please do not exercise your dogs near the entrances to the MAX or on the shrubbery. Anyone caught not picking up after their dog(s) will be asked to leave without a refund. Remember, hotels are considered by the AKC to be part of the trial site, so exhibitors observed not picking up or causing disturbances at the hotels may face AKC sanctions. Please discard your pet waste in the nearby dumpsters.

**Food** will not be available on site. Please bring water for you and the dogs.



**Crating areas** will be marked, and available on upper and lower levels; an elevator is in the building to use. **RINGS 1 and 2 are available for crating on Friday.** Please conserve your space; place your chair in front of your crate.

All crates and x-pens must have a mat or blanket under them to protect the flooring; the top of the crate must be closed. Please be aware there is reserved space for vendors and club members.

- Blitzen Agility Club of Chicago and AgilGold Trial Svcs will not be responsible for any lost or damaged items left at the show site. Keep your valuables hidden and bags closed.
- Dogs with space issues must be covered and non-disruptive.

**Measuring Dogs:** Please see the secretary if your dog needs to be measured. There will be VMO's present. If you need to be measured and run without being measured first, AKC will remove any legs you may have earned. Novice Handlers that require a 1<sup>st</sup> measurement should arrive at least 45 minutes before your first run.

**Unless getting ready to compete, dogs will NOT be allowed by ring fencing.**



*Please be aware of other teams as you enter and exit the building. Doorways can be tight; keep your dog close and look before you suddenly turn the corner.*

## RESULTS/AWARDS

- ❖ Preliminary results will be displayed on monitors in front of the secretary's table and posted as a jump height/class is completed.
- ❖ Ribbons & Stickers will be self-serve.
- ❖ Individual results will be emailed Monday morning after the trial.

## GENERAL INFORMATION

- ❖ **If you are ill or have been in contact with someone with COVID-19 in the last 14 days, or if you or someone in your home has had symptoms in the last 24 hours, STAY HOME!**

## DIRECTIONS:

From I-294:

Exit I-294 at Ogden Ave. East. Continue on Ogden Ave. for 2.6 miles. Turn RIGHT on East Ave. and continue for 0.8 miles to 47<sup>th</sup> Street. Turn LEFT onto 47<sup>th</sup> Street. Continue for 0.8 miles. Turn RIGHT onto Vernon Ave. MAX is the large orange building on the right.

From I-55:

Exit I-55 at IL-171 North. Continue on IL-171 for 1.2 miles. Take the 47<sup>th</sup> Street Ramp exit and turn LEFT onto 47<sup>th</sup> Street. Continue on 47<sup>th</sup> Street for 0.6 miles. Turn LEFT onto Vernon Ave. MAX is the large orange building on the right.

This is the Preliminary Judging Schedule which is contingent on move-ups/withdrawals not yet received.

Running Order within each height will be:

Master, Master Preferred, Exc, Exc Preferred, Open, Open Preferred, Novice B, Novice A, then Novice Preferred.

Walk-thru sizes will be split at the Judges' discretion.

**NOTE: In order to expedite the efficient running of the trial, Jump Height Order is subject to change.**
